Total price double chip seal of 5785 feet of county roads and includes \$15,721.03 for Prime coat MC30, \$4.03 per gallon; \$33,930.00 for CRS-2P, \$3.48 per gallon; \$7,261.25 for Mineral aggregate (class 2), \$39.25 per ton; \$2,500.00 for maintenance of traffic, and \$3,400.00 for mobilization.

1.1	This work consists of single and double chip sealing county roads. Single coat chip seal shall be applied to existing blacktop roads or specified aggregate base roads. A prime coat and single or double chip seal shall be applied as specified to aggregate base roads as furnished, shaped, and compacted by Craighead County Highway Dept.
Note: Bidders may contact Eugene Neff at the Craighead County Road Department at 870-933-4510 for specifics on road location and part of roads to be chip sealed.	
Craighead County 2017 Chip Seal Bid Proposal	
Arkansas State Highway and Transportation Department (AHTD) specifications will be used in bidding Craighead County's chip seal projects. The Construction Requirements will adhere to Section 402 and the Materials and Equipment will adhere to Section 403 of the Standard Specifications for Highway Construction, AHTD Edition of 2014 or the latest EHTD Edition.	
MC-30 will be used for the prime coat application, CRS-2P will be used as the liquid asphalt in the chip seal application, and Class 2 Mineral Aggregate will be used as the cover aggregate in the chip seal application. In the case of a double chip seal application, the second seal shall be applied the day following application of the first seal, weather permitting. Sweeping is required after each chip seal application and shall be completed the morning following each application.	
The MC-30 shall conform to AHTD Section 403.03(b) and must meet the requirements of AASHTO M 82. MC-30 must come from an approved supplier listed on the AHTD Qualified Producer's List (QPL) and shall be applied in conformance to AHTD Section 401.03(b).	
The CRS-2P shall conform to AHTD Section 403.03(e). CRS-2P must come from an approved supplier listed on the AHTD Qualified Producer's List (QPL).	
The Class 2 Mineral Aggregate shall conform to the requirements of AHTD Section 403.01 and the gradation specifications of Section 403.02.

Description:

The intent of the specifications is to provide bidders with the scope to govern workmanship of the related project(s) and to attest to the materials used on the project(s) located in Craighead County.

The successful bidder will furnish Craighead County with signed documentation of all delivery receipts and quantities used on each road. The prime coat should be applied at a rate of .30 gallons per square yard, unless the contractor and county agree upon a different rate for the betterment of the project(s). An Asphalt Surface Treatment design should be submitted prior to beginning the first project. This design should detail the CRS-2P and Class 2 Mineral Aggregate application rates. For the purpose of bidding, a CRS-2P rate of .35 gallons per square yard for the first treatment and a rate of .40 gallons per square yard for the second seal shall be used. An aggregate application rate of 28 pounds per square yard shall be used. These rates may change based on the results of the Asphalt Surface Treatment Design. The successful bidder will be paid based on actual quantities used on each project.

The Pay Unit will be based off of the materials applied in place on each project. This price will include materials, equipment, labor, insurance, and all other related costs, including applicable taxes.

An authorized representative of each bidder must sign all bids.

The bid may be awarded after stringent review of all factors including, but not limited to, price, availability, quality, performance, workmanship, references, viewing recent and dated jobs of contractor, and other relative factors.
