
ORDER

Reinforced Concrete culvert pipe

1. All pipe shall conform to and meet all Arkansas State Highway and Transportation Department specifications, and shall meet all the specifications in this bid package minimally.

2. Any deviations from specification in this bid package shall be clearly noted.

3. Craighead County reserves the right to accept, reject, in whole or in part, to waive informalities in bids received or accept bids with variations.

4. It is the intent of Craighead County to receive bids to furnish reinforced concrete culvert pipe. It is expressly understood that the County does not obligate itself to purchase any specific quantity or to make purchases at any specific time. It is further understood that the material shall be delivered to any job site within the County or to the Road Department Shop with no quantity minimum.

5. Bid items shall meet Arkansas Highway Department Specifications as set forth in Section 606

6. The reinforced concrete pipe sections shall be manufactured in accordance with specifications AASHTO M 170 or ASTM C 76. The pipe shall have a tongue and groove joint so when joined together the pipeline forms a uniform exterior with no extended bells at the joints, which would require bell holes when installing the pipe.

7. All pipe furnished to Craighead County will meet the same standards and requirements as required by the Arkansas State Highway and Transportation Department and shall have the appropriate stamp that verifies the approval.

8. All pipe shall be subject to rejection on account of failure to conform to any of the specifications requirements. Individual sections of pipe may be rejected because of any of the following:

- a. Fractures or cracks passing through the wall, except for a single end crack that does not exceed the dept of the joint
- b. Defects that indicate proportioning, missing, and molding not in compliance with 10.1 or surface defects indicating honeycombed or open texture that would adversely affect the function of the pipe.
- c. The ends of the pipe are not normal to the walls and center line of the pipe, within the limits of variations given in 12.3 and 12.4
- d. Damaged or cracked ends where such damage would prevent making a satisfactory joint.
- e. Any continuous crack having a surface width of 0.01 inches or more and extending for a length of 12 inches or more, regardless of position in the wall of the pipe.

Craighead County reserves the right to accept or reject any and/or any portion of any bid received.

6.	Identical Bids		
6.1.	In the event of two or more identical bids, the contract may be awarded arbitrarily or for any reason to any of such bidders, or split in any proportion between the said two or more bidders at discretion of the County. In all cases where there are identical bids, preference shall be given to residents or firms located and doing business in the county.		
7.	Default		
7.1.	Back orders, default in promised delivery, or failure to meet specifications authorize the County to cancel this contract to the defaulting contractor. The contractor must give written notice to the County of the reason and the expected delivery date.		
8.	Reservations		
8.1.	The County reserves the right to reject any and all bids, accept in whole or in part, to waive informalities in bids received, to accept bid with or without trade-in, to accept bids on materials or equipment with variations from specifications in those cases where efficiency of operation will not be impaired, and unless otherwise specified by bidder, to accept any item in the bid. If unit prices and extensions thereof do not coincide, the County may accept the bid for the lesser amount whether reflected by extension or by the correct multiple of the unit price.





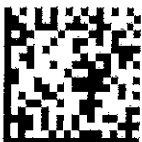
