An Ordinance amending the 2022 Annual Operating Budget to add Fund 3536, Small Rural Tribal (SRT) Body Worn Camera Grant, Department 0400, Sheriff's Office, to include grant monies that have been awarded to Craighead County with a 1:1 match being transferred from County General unappropriated funds. These funds should be incorporated into the 2022 Craighead County Annual Operating Budget and processed according to grant requirements for disbursing of these grant funds.

**Section 1.** That \$36,000 in federal grant monies has become available from the Small Rural Tribal (SRT) Body Worn Camera grant and the funds are to be used to purchase body worn cameras for the Craighead County Sheriff's office. This grant requires a 1:1 match and this Appropriation Ordinance authorizes the Craighead County Treasurer to transfer the required match of \$36,000 from Fund 1000, County General unappropriated funds to Fund 3536.

**Section 2.** That Fund 3536, SRT Body Worn Camera Grant, Department 0400, will be created in the 2022 Annual Operating Budget to allow for accurate tracking, disbursing and accounting of the remaining grant funds..

These funds shall be established in the chart of accounts by the County Treasurer and entered into the accounts payable appropriations journal by the County Clerk as described upon passage of this appropriation ordinance.
