APPROPRIATION ORDINANCE NO. 22-30

BE IT ENACTED BY THE QUORUM COURT OF CRAIGHEAD COUNTY, ARKANSAS; AN ORDINANCE TO BE ENTITLED:

An Ordinance amending the 2022 Annual Operating Budget to add Fund 3532, Department 0422, BJA FY22 Adult Drug Court Discretionary Grant Program grant monies that have become available to Craighead County. Craighead County was awarded a \$750,000.00 federal grant for a period of four (4) years beginning October 1, 2022, with year one being prorated through December 31, 2022.

SECTION 1. The purpose of the BJA FY22 Adult Drug Court Discretionary Grant Program is to reinforce the value of and adherence to treatment with mental health and co-occurring mental health and substance abuse disorders, using a range of sanctions and incentives tailored toward each defendant's needs, abilities, progress, and level of risk- to-self or others to achieve twin goals of public safety and treatment compliance.

SECTION 2. That these grant monies are recognized as special revenue and will be established in a separate fund in Craighead County and should be incorporated into the 2022 Craighead County Annual Operating Budget and processed according to grant requirements. This grant will allow for the improvement of the lives of participants with mental health and co-occurring mental health and substance use disorders in the criminal justice system through the integration of intensive supervision, alcohol and drug treatment, mental health services, alcohol and drug testing, and case management services with criminal justice system processing.

SECTION 3. That these funds are special revenue and Fund 3532, BJA FY22 Adult Drug Court Discretionary Grant Program will be created in the 2022 Annual Operating Budget to allow for accurate tracking, disbursing, and accounting of these funds and will include budget totals as described below.
