
SECTION 1. That State Grant monies have become available through the Arkansas Department of Public Safety and Act 786 of 2021 and Craighead County was awarded \$48,572.56 to purchase body worn cameras, non-lethal tasers and other necessary equipment to provide for Detention Center officers safety.


