APPROPRIATION ORDINANCE NO. ##-# 24-13

BE IT ENACTED BY THE QUORUM COURT OF CRAIGHEAD COUNTY, ARKANSAS; AN ORDINANCE TO BE ENTITLED:

An Ordinance amending the 2024 Annual Operating Budget to add Fund 3048, Department 0422, Adult Drug Court - Opioid Settlement for funds that have become available to Craighead County for allowable supportive and restorative services for the Adult Drug Court to aid in financing different aspects of the program.

SECTION 1. All monies have become available through the Supreme Court of Arkansas, Administrative Office of Courts and Craighead County has been awarded \$28,899.70 to pay for transitional/recovering housing, treatments, educational programs, and other services that benefit Adult Drug Court.


SECTION 2. That this fund is considered to be special revenue and Fund 3048 will be created in the 2024 Annual Operating Budget to allow for accurate tracking, disbursing, and accounting of these funds and will include budget totals as described below.
