May 13, 2013 Quorum Court Meeting

11 Justices of the Peace Present. Justice **Kenny Hendrix** joined a short time after the meeting began. Justice **Max Render** was absent.

Judge **Ed Hill** called the meeting to order.

Judge **Hill** noted a slight setback with the Bono Lake due to flooding associated with the rain.

County Clerk **Kade Holliday** read Ordinance 2013-05 – *Appendix 1*. Justice **Barbara Weinstock** made a motion to pass the ordinance, it was seconded by Justice **Fred Bowers**. The ordinance passed 11-0 with Justice **Render** absent. Justice **Ken Stacks** noted that the cost of printing the ordinance will be close to the amount of the grant.

County Clerk **Holliday** read Ordinance 2013-06 – *Appendix 2*. Justice **Stacks** made a motion to pass the ordinance, it was seconded by Justice **Bowers**. The ordinance passed 11-0 with Justice **Render** absent.

Charles Curtis addressed the Court concerning County Road 460. He noted that the County does not maintain part of the road, even though school buses and county trucks regularly use the road. **Jack Spain** added that more than 30 people live on that part of the road. He also said that rain tends to wash out the road and the road continues to get lower and lower. He said that if the road was built back up, it would not flood.

It was noted by several in the room that particular part of the road was not a county road and did not meet county road standards.

Justice **Bowers** suggested that Judge **Hill** and Road Superintendent **Eugene Neff** go out to the road and check it out. Judge **Hill** also suggested that the Road Committee discuss the matter further.

John Reeves stated that if the county can build a lake, it can build 4/10 of a mile of road. Judge **Hill** said that there are several roads throughout the county just like this and that 4/10 of a mile could quickly turn into 200 miles.

Justice **Kevin Hoke** suggested that the Court hold an Elected Officials meeting soon. The meeting was set for 6 PM on May 28 before the next Quorum Court meeting.

Justice **Kevin Hoke** made a motion to adjourn the meeting. It was seconded by Justice **Mike Hawkins**. The meeting was adjourned.

*** Also distributed to the Court was the monthly Road Report (*Appendix 3*) and the monthly Sheriff's Report (*Appendix 4*).

BE IT ENACTED BY THE QUORUM COURT OF CRAIGHEAD COUNTY,
ARKANSAS; AN ORDINANCE TO BE ENTITLED:

An Ordinance amending the 2013 Annual Operating Budget to add Fund 3503, Dept 0116, to include grant monies that have become available to Craighead County to complete an Economic Development Program off State Hwy 1 South in Craighead County and that these grant funds should be incorporated into the annual operating budget.

SECTION 1. That these grant monies in the amount of \$499 will be administered through the East Arkansas Planning and Development District and will be the final payment and thereby fulfilling all administrative obligations associated with the Windmill Rice Economic Development Grant Project.

SECTION 2. That these grant monies are considered to be special revenue funds and must be expended for the purpose so indicated in the grant program specifications. Grant funds will be a pass-thru process to Craighead County to pay for expenditures as various parts of the project are completed and expenses are incurred.

SECTION 3. That this new fund, department, and line categories will be created in the 2013 Annual Operating Budget to allow for accurate accounting of grant monies and expenditures, and listing increases in projected special revenues as described below.

BE IT ENACTED BY THE QUORUM COURT OF CRAIGHEAD COUNTY,
ARKANSAS; AN ORDINANCE TO BE ENTITLED:

An Ordinance amending the 2013 Annual Operating Budget to add Fund 3023, Dept 0503, Fire Equipment and Training (Act 833) Fund, to comply with Attorney General Opinion No. 2012-007 and ACA 14-14-1102 in receiving and disbursing Act 833 monies received from the Arkansas Department of Finance and Administration in assisting fire departments operation.

SECTION 1. That these monies shall be utilized in accordance with the established guide lines for equipment, training, capital improvements, or other expenditures necessary for upgrading the service provided by the department. Funds shall be apportioned by the quorum court to the districts and municipalities within the county based upon agreement of the Craighead County Intergovernmental Cooperative Council concerning distribution of Act 833 monies to to certified departments. Act 833 funds shall be receipted and disbursed according to actual amounts received for each certified fire department.

SECTION 2. That these monies shall be received and receipted in fund 3023, Revenue Code 7011 in the Treasurers chart of accounts and distributed by appropriation ordinance and shall be processed through the regular claims process with all vouchers for payment of county funds of the county treasurer, shall be approved and filed by the County Judge.


SECTION 3. That this new fund, department, and line categories will be created in the 2013 Annual Operating Budget to allow for accurate accounting of incoming monies and expenditures, and listing increases in projected special revenues as described below.

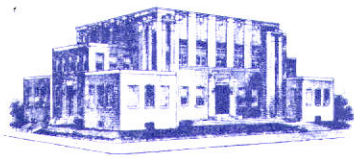
