June 23, 2014 Quorum Court Meeting

13 Justices of the Peace present.

Judge Ed Hill called the meeting to order.

Justice Barbara Weinstock moved to approve the minutes from the previous meeting. The motion was seconded by Justice Brett Provost.

Justice Ken Stacks read the minutes from the Public Services Committee meetings of June 9, 2014 – *Appendix 1*

Justice Jim Bryant read the minutes from the Finance Committee meeting of June 9, 2014 – *Appendix 2*

Justice Weinstock asked where records are stored presently. Judge Ed Hill said records are currently stored in the safe room but this will need to be changed. Justice Bob Blankenship stated that the building up for discussion could potentially be used for storage and that it is in a growing area. Justice Kenneth Hendrix suggested creating a committee to explore the building purchase.

Justice Ray Kidd inquired about the issue of overtime, asking the opinion of those on the Finance Committee Meeting. Justice Blankenship said this will be looked at during Budget discussions in September.

Justice Terry Couch read the minutes from the Road Committee meetings of June 9, 2014 – *Appendix 3*

Justice Provost inquired about the state of the roads, indicating that Lawson Road was very difficult to drive. Justice Michael Hawkins also asked about the progress of the roads around the county. Judge Hill said progress is being made when weather permits and while the roads were bad they could be worse.

Ordinance 2014-3 was read – *Appendix – 4*. Justice Ken Stacks moved to pass the Ordinance. Justice Weinstock seconded. Passed unanimously.

Ordinance 2014-9 was read – *Appendix – 5*. Justice Fred Bowers moved to pass the Ordinance. Justice Provost seconded. Passed unanimously.

Ordinance 2014-10 was read – *Appendix – 6*. Justice Provost moved to pass the Ordinance. Justice Hawkins seconded. Passed unanimously.

Sheriff Marty Boyd distributed the Monthly Sheriff's Report – *Appendix - 7*. Boyd then discussed a contract with Brookland School for the hiring for two Deputy Sheriff's as Resource Officers, one for the elementary school, the other for the high school. Boyd said they would provide the officers with vehicles but outfitting the officers would be an expense they could not cover. Boyd asked the Court to make a motion so the Sheriff's department could proceed with

the contract. Motion to approve was made by Justice Weinstock. Justice Bryant seconded. Passed unanimously.

Judge Hill updated the Court on Lake Bono. Justice Hawkins asked the Court if they would object to owning Lake Bono. Justice Longmire and Justice Hendrix questioned the amount of liability that comes with the lake. Judge Hill said ownership of the lake would take two years or more. Justice Longmire suggested discussion on this matter continue after more details have been worked out.

Justice Bryant moved to adjourn. Justice Couch seconded.

Craighead County Quorum Court Meeting
Public Service Committee
JUNE 9, 2014

Public Service members assembled after full court business. Chairperson Ken Stacks called the meeting to order. Those present were Ken Stacks, Barbara Weinstock, and Josh Longmire, and Fred Bowers.

Recommendations for appointments and reappointments for the Jonesboro/Craighead County Library Board of directors were brought before the Public Service Committee:

1. Appointment for Curt Hawkins to replace Ralph Waddell.
2. Reappointment for James Dunivan for a second term.

Third reading regarding approval of an updated policy Handbook for Craighead County employees.

With no more business to discuss, Ken Stacks made a motion to adjourn, seconded by Fred Bowers. All members approved, and meeting closed at 7:35 p.m.

Finance Committee Meeting

June 9, 2014

Finance Committee Members present: Chairman Jim Bryant and Justices Bob Blankenship, Dana Watkins, Kenny Hendrix, and Brett Provost.

Others present: Al Haines, County Clerk Kade Holliday, County Treasurer Terry McNatt, County Collector Marsha Phillips, Deputy Collector Teresa Presley, and Sheriff Marty Boyd.

Justice Bryant called the Finance Committee Meeting to order at 7:10 PM after the full court meeting and discussed the following:

Reviewed revenue and expenditure reports for May 2014.

County Clerk Kade Holliday asked the court to consider paying his election workers overtime pay in lieu of comp time since the court voted to pay three employees for Quorum Court meeting. He said his election workers prefer overtime vs. comp time. Sheriff Marty Boyd interjected that if election workers are paid overtime, then he has several employees that work overtime hours and would want the same consideration. Additionally, it was noted that the Road Dept would have to be considered. Boyd suggested that over time issue should be considered county wide. This issue will be considered by full court. It also was noted that work on next year's budget should begin early so that all issues may be fully explored without making rush decisions.

Sheriff Boyd noted that Brookland Schools is considering contracting with the County Sheriff's Office for a School Resource Officer. He should have more information in two weeks. Start date will be August 1st if approved.

County Treasurer Terry McNatt noted that the County Treasurer and County Clerk books balanced to the penny. He also reminded the committee to look at increasing the chief deputies pay next year.

Justice Hendrix noted that elected officials should be given more control over pay increases within their offices, with a range set by the Quorum Court, to reward those employees that work above and beyond normal duty.

Justice Blankenship informed the committee that there is a fourth building adjacent to the Sheriff's Office for sale at the strip mall in Lake City. This mall complex houses the Lake City Courthouse, District Court, and Sheriff's Office. Asking price is \$80,000. Blankenship recommends that the County purchase this building for future expansion, storage of records, rent, or other uses. No action taken.

With no other business to be discussed, the Finance Committee stood adjourned at 7:40 PM.

Craighead County Quorum Court Meeting
June 9, 2014
Roads and Transportation Committee

Members of the Roads and Transportation Committee assembled after the meeting of the full court. Members present included: Terry Couch, Mike Hawkins, and Ray Kidd.

Others present included Judge Ed Hill, Eugene Neff—Road Superintendent, and Ty Koons.

Justice Couch called the meeting to order at 7:12 pm and the following business was discussed:

1. Eugene Neff delivered his monthly road report (also distributed to the full court) and updated the committee regarding on-going projects. There was no damage at the main shop related to the recent weather event. The Black Oak shop did sustain some damage to doors. Justice Couch expressed appreciation for the road clearing assistance provided by road employees to some of the smaller cities.
2. Justice Hawkins inquired about the need for a better sweeper for use after heavy rains. He indicated this could be helpful in moving gravel back from paved surfaces at road intersections. Judge Hill indicated he would look at pricing for a used one.
3. Justice Kidd requested the Road Department look at some road issues that have recently appeared on Lawson Road with Neff indicated there had been no calls but he would be sure crews followed up on it. More discussions related to the impact of the winter weather on county roads followed.
4. Equipment Updates—The 3 newly ordered pick-ups were received this week. Receipt of the dump trucks is anticipated near the beginning of July.

With no other business, the committee adjourned at 7:33 pm.

Section 1. A need to update the County Employment/Personnel Policy was necessary due to changes to remain compliant with existing law.


