PUBLIC COMMENT

QUORUM COURT MINUTES August 12, 2024

The invocation was led by Pastor Don Blackmore, Central Baptist Church.

Meal was served by the Craighead County Cooperative Extension Service.

Justice Cline called meeting to order at 5:45 p.m.

The Pledge of Allegiance was recited.

Roll was called, Justice Pasmore and Justice Barnes were absent. All others present.

The meeting began with the Craighead County Cooperative Extension Service introducing the 4-H agent, Malia Cook for a presentation. Malia introduced Abigail Patron, first ever State officer from our local chapter. Abigail shared with the court of her project, Blessing Backpacks. She collects blankets, hygiene products, and assorted arts and crafts, and has donated over 1,000 backpacks the last couple of years. For her work and leadership, the Craighead County 4-H chapter awarded Abigail with a \$1,500.00 scholarship to attend ASU this fall. She has also garnered over \$5,000.00 of additional 4-H scholarships.

First order of business was approval of Quorum Court minutes from July 22, 2024. Justice Weinstock made the motion to approve minutes as prepared and Justice Allison seconded the motion. Justice Cline took a vote, and it passed unanimously.

The Public Service Committee report was read by Justice Rogers and the Finance report was read by Justice Longmire.

NEW BUSINESS

A resolution recommending the appointment of Sydney Ford to the Jonesboro Craighead County Public Library Board was read. Justice Rogers made a motion to approve, and Justice Williams seconded. With no questions or comments, Justice Cline took a vote, and it passed unanimously.

An Appropriation Ordinance to add Fund 3535, CY24 Accountability Court Grant Adult Drug Court Funding was read. Motion to approve was made by Justice Couch and seconded by Justice Cook. With no questions or comments, Justice Cline asked for the roll to be called. All Justices approved.

Justice Forrest shared that the Exchange Club of Jonesboro donated \$12,000.00 to the County Sheriff's office to buy the new dog that we had budgeted to buy.

Transportation Committee Meeting Minutes 8/12/2024

Justice Cline called the meeting together at 5:59 p.m. Those present were Justice Couch, Justice Tennison, and Road Superintendent John James. John James gave us an update on road work. The committee reviewed a plat for Nathan Hay. Justice Tennison made a motion to approve, seconded by Justice Couch; all were in favor. With no other business, Justice Couch motioned to adjourn, seconded by Justice Tennison. The meeting adjourned at 6:05 pm.

Public Service Committee 08/12/2024 Minutes

The Public Service committee meeting was called to order at 5:10 p.m. by Chairman Rogers.

Chairman Rogers opened the meeting with a resolution recommending that Jason Arender fill a five (5) year term as a board member to the Philadelphia Fire Protection District Board of Directors. His term will become effective August 27, 2024. Justice Noel made a motion to approve, and Justice Williams seconded the motion. The motion passes 4-0 to move to the full court.

A resolution was read for the recommendation of the reappointment of Dr. Kevin Diamond to the five (5) year term as a board member to the Bono Fire Protection District Board of Directors. His term will become effective on August 27, 2024. Justice Williams made a motion to approve, and Justice Allison seconded the motion. The motion passes 4-0 to move to the full court.

The next resolution was a recommendation for the reappointment of two board members, Derek McCormick of Lake City and Bob Blankenship of Monette, to additional three (3) year terms to the Craighead County Solid Waste Board. Their new terms will also be effective on August 27, 2024. Justice Noel made a motion to approve, and Justice Williams seconded the motion. The motion passes 4-0 to move to the full court.

The last resolution was a recommendation of Jim Gramling of Jonesboro to be appointed to the Craighead County Nursing Center Board of Directors for a five (5) year term, effective September 1, 2024. Justice Williams made a motion to approve, and Justice Allison seconded the motion. The motion passes 4-0 to move to the full court.

With no other business, Justice Williams made a motion to adjourn, and Justice Noel seconded the motion. All approved, and the meeting was adjourned at 5:15 p.m.

Finance Committee Minutes August 12th, 2024

Justice Longmire convened the Finance Committee meeting at 5:59 p.m. Those present included Committee members Justice Cook, Justice Weinstock, Justice Forrest, Treasurer McNatt, Collector Eddington, County Clerk MaryDawn Marshall, and Circuit Clerk David Vaughn.

Collector Eddington presented the tax collection report, stating that the total tax collected in July of 2024 was 2.1 million which was \$650,000 less than July of last year. However, the county was still up 13.2% on total tax for 2024. There were no questions from the committee to Collector Eddington as he finished his report.

During the overview of July's financial reports, Treasurer McNatt highlighted that we finished the month with a balance of \$46.4 million in the general ledger. Additionally, we have \$3.2 million in County Capital funds and \$7.4 million in Road funds. Treasurer McNatt stated that sales tax was down in July but still brought in \$2.4 million. As of July, the county has 59.8% of the budget left for the fiscal year of the original \$69.8 budget. Also, Treasurer McNatt addressed the committee that the county revenues are up but so are expenditures with the ongoing Courthouse Annex construction. Justice Cook inquired about the budget status for the Courthouse Annex project, and Treasurer McNatt confirmed that we were on track. He assured Justice Cook that he would send those details via email.

Justice Cook motioned to adjourn, with no other business. The motion was seconded by Justice Forrest. All were in favor, and the Finance Committee adjourned at 6:08 p.m.
