

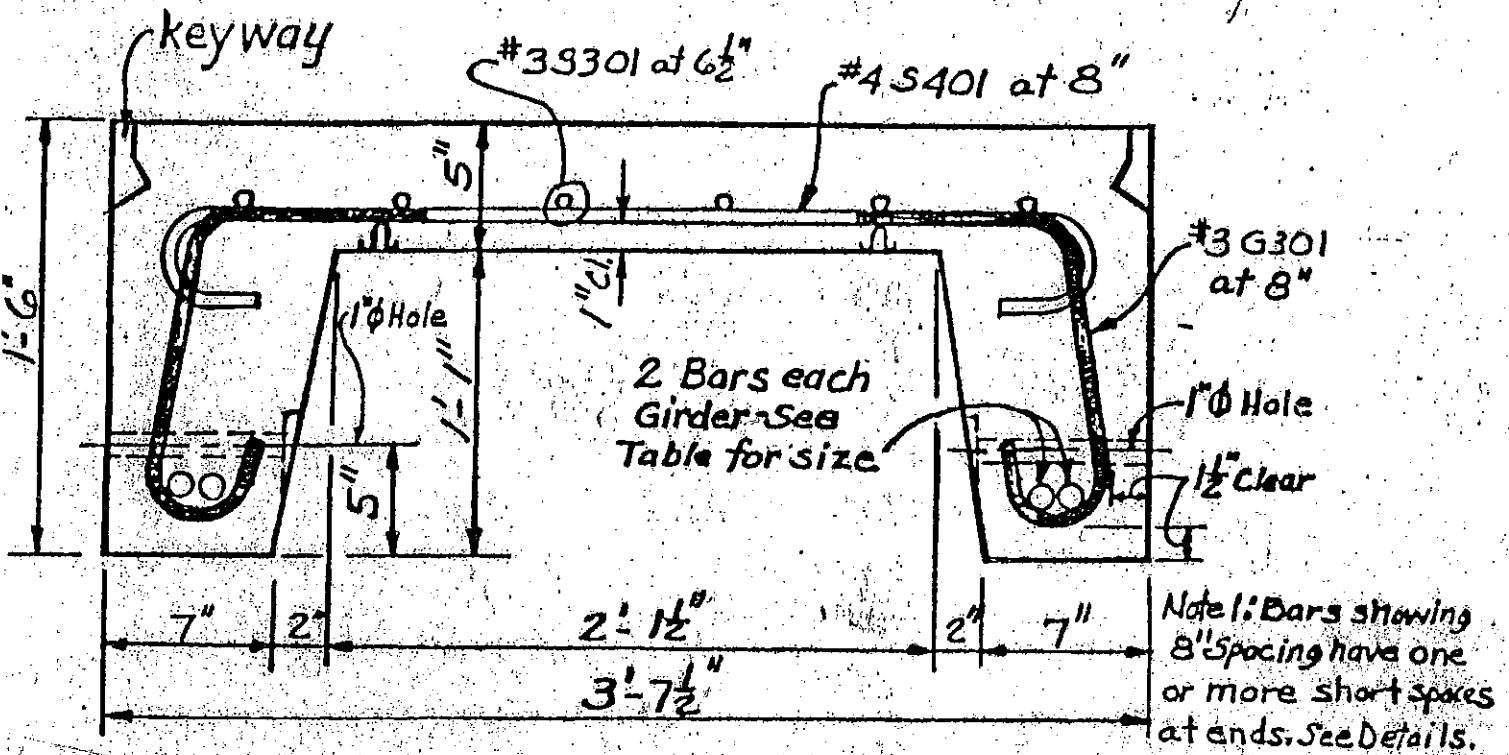

Pre-cut and Pre-formed Concrete Reinforcing Bar Steel Specifications

1	Bidder should quote on one (1) full truck load of pre-cut and pre-formed concrete reinforcing bar to be used in the county's pre-cast concrete bridge program. (See attached sheets)
2	Reinforcing bar shall be grade 60.
3	Reinforcing bar is to be pre-cut and pre-formed according to attached specifications.
4	The County will buy a full truck load delivered F.O.B. to the Craighead County Highway Department, 2800 Moore Road, Jonesboro, Arkansas 72401.
5	The County would like to buy one (1) full truck load of reinforcing steel for 30 foot (30') span bridge units.
6	Each 30 ft. bridge span will consist of seven (7) standard interior bridge panels to make one (1) complete bridge. <u>Craighead County is not using curb unit panels.</u>
7	The bidder will need to calculate the number of thirty foot (30') spans, figuring seven (7) standard interior panels per complete bridge, to make up a complete truck load of steel reinforcing bars.
8	Bidder should calculate number of interior standard panels to form complete bridge units.
9	Bidder should quote the "Rib Bar": (Noted with asterisk) in a one (1) piece bar that would be strong and perform as well as the three piece, and that being a #4 bar.
10	The successful bidder should pack and ship the re-bar in a manner that will prevent damage and permit easy handling of the steel.
11	Bidder should list the total pounds of steel making up the full truck load
12	Any variations from the above specifications should be listed on a separate sheet of paper and attached to bid. This sheet should be labeled as such.

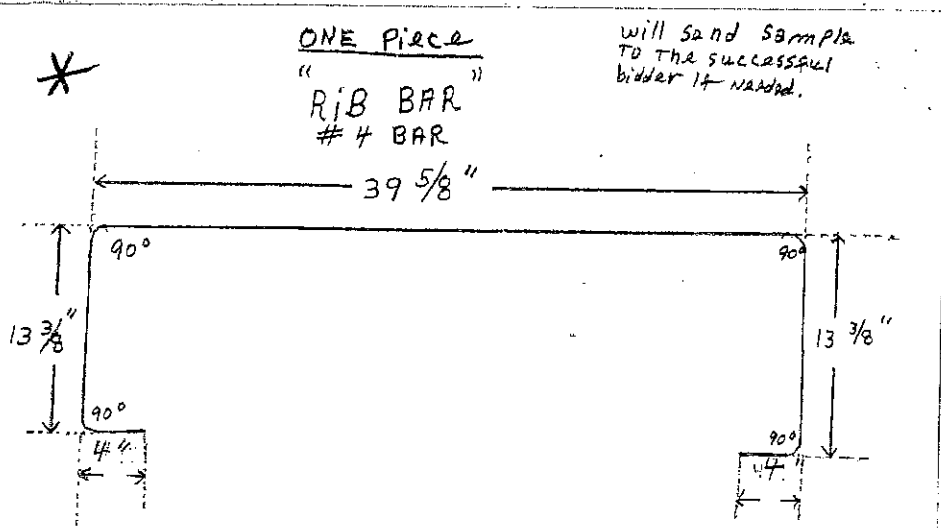
CROSS SECTION - INTERIOR UNIT

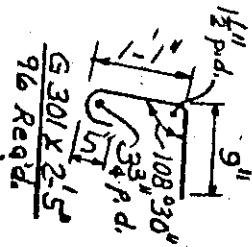
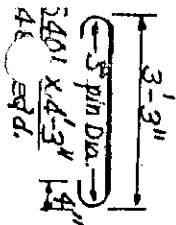

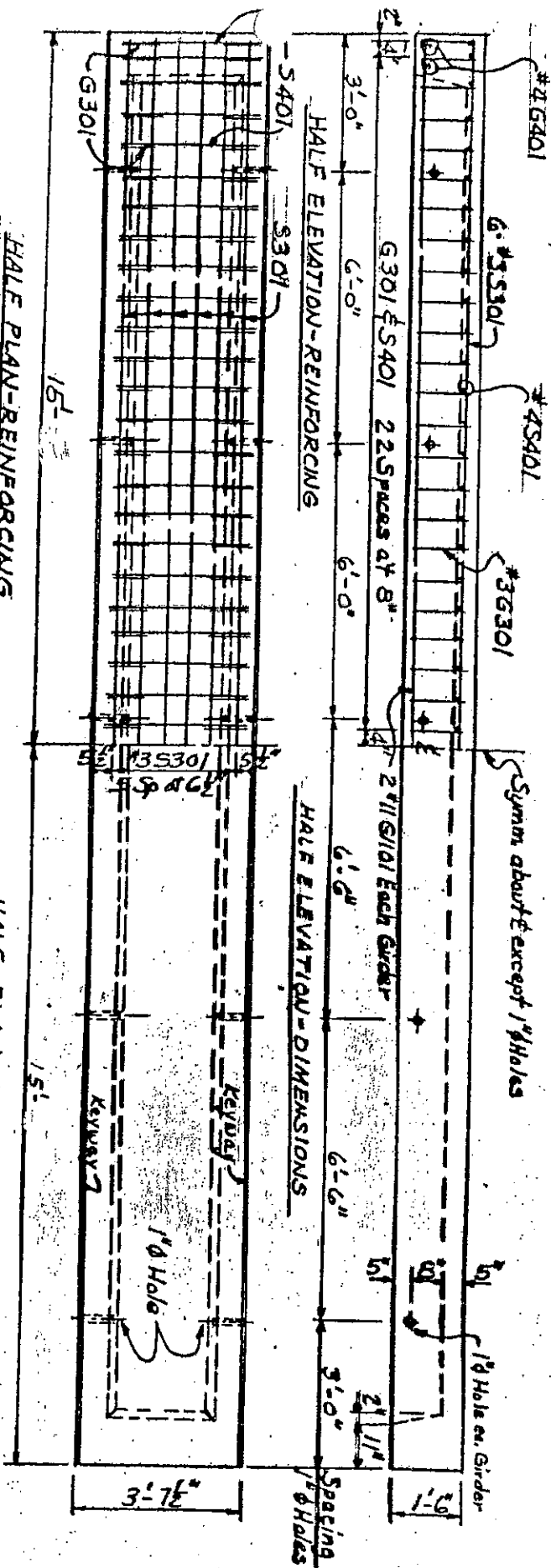
HALF PLAN-REINFORCING.


