Bono Fire Protection District was formed under Act 742 of the 75th General Assembly of the State of Arkansas. The main purpose of the formation of the fire district is for fire protection of rural areas and to assist smaller communities with fire protection when needed.

Bono Fire Protection District has 2 contracts, one with Tammy Willard, for book keeping for \$1,000.00/year and one with Parrish Lawn Care for \$4,500.00/year.

We also have a loan for a with Evolve bank for a 2018 Freightliner pumper for \$ 227,509.09 with an expected payoff of 2023.

We have existing delinquent assessments totaling \$8,770.00 and the county assessor works to collect this.

Board members are appointed by the Craighead County Judge for a term of 5 years. Current board members are as follow:

The county tax collecto will add a 10% penalty to delinquent assessments for collection after January 1 of each year.

The county treasurer sends monthly payments to the board treasurer's address. The treasurer then deposits the checks into the appropriate account, obtains a deposit receipt, and attaches this receipt and the check stub to the monthly statement after reconciliation with the receipt.

When it is determined that our current funding is inadequate to cover costs, the board discusses fee amounts and comes up with a reasonable fee that will fund the department's requirements well into the future.
